

Official Rules and Regulations – Deer Valley Credit Union Member Satisfaction Survey

NO PURCHASE OR OBLIGATION IS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

To Enter: Your completed survey (complete with name and email address) will automatically enter you in our weekly drawing. NOTE: Only one entry per person will be accepted for all four weekly drawings combined. You need not be present to win. All entries become the property of Deer Valley Credit Union. Any excess entries will be discarded. All entries must be received by 11:59 p.m. MST on August 9, 16, 23 or 31 to be entered into the weekly drawing. If you wish to enter the drawing, but do not want to complete a member survey, you may enter at our Main branch location (16215 N. 28th Avenue, Phoenix, AZ 85053).

Eligibility: Sweepstakes is open to legal residents of United States who are 18 years of age or older as of August 1, 2019. You must be a lawful, permanent resident of the United States to enter. You must be a member of Deer Valley Credit Union to enter. Deer Valley Credit Union employees and volunteers are not eligible to participate.

Drawing: A total of one drawing will be held on August 12, 19, 26 and September 3, 2019, for the previous week. The winner will be chosen through a random drawing by Deer Valley Credit Union from entries received the week prior. If the winner refuses or if the prize notification is returned to the credit union as undeliverable, an alternate winner will be selected. No substitution for prizes is allowed. Odds of winning will be determined by the number of entries received. The estimated odds of winning a prize are 1:750.

Prizes: A total of four (4) \$100.00 Visa cards (\$100.00 value each) will be awarded during the month of August to a randomly selected winner each week for a total of four (4) winners. The winner is responsible for all federal, state and local taxes where applicable. Deer Valley Credit Union may report the value of the prizes on IRS form 1099-MISC. Prizes are non-transferable. Prizes may and can change at any time.

Prize Notification: Potential winner's eligibility will be verified and prizes can be picked up at our Main branch location (16215 N. 28th Avenue, Phoenix, AZ 85053). Items may be sent by mail to the address of record on your account if you are unable to pick up in person.
